Tim Brindley said maybe the lifeguards could use apple phones. Sarah Lambert, 1609 Seaview Avenue, said maybe we just need some education to the people who renew their dog tags. She said that we could hand out a piece of paper with all the rules. Allan Canter, 1 West 29th Street, beach rules signs at the street ends are a lot to read, he suggested a stand alone sign for the dog rules.

AN ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING SECTION 21-46 OF THE BOROUGH CODE, ENTITLED "ZONING FEES," TO REVISE THE SAME

SECTION 1. Section 21-24 of the Borough Code of the Borough of Barnegat Light, entitled "Zoning fees," is hereby amended and supplemented to provide as follows:

Article VI Schedule of Fees

AN ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING SECTION 215-16 OF CHAPTER 215 OF THE BOROUGH CODE, ENTITLED "ZONING," TO INCREASE THE ZONING OFFICER'S ENFORCEMENT POWERS.

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

SECTION 1. Section 215-16 of Chapter 215 of the Borough Code of the Borough of Barnegat Light, entitled "Administration and enforcement," is hereby amended and supplemented to revise paragraph B to provide as follows:

Chapter 215 ZONING

§ 32-52. Administration and enforcement.

. . . .

B. Zoning Officer.

- (1) There is hereby created in the Borough of Barnegat Light the position of Zoning Officer, who shall have the following duties:
- (a) To enforce the zoning ordinances of the Borough of Barnegat Light.
- (b) To issue zoning permits in accordance with this chapter.
- (c) To answer all inquiries with regard to zoning questions in the Borough of Barnegat Light.
- (d) To keep a record of all applications for permits and of all permits and certificates issued with a notation of all special conditions involved.
- (e) To collect and record fees for zoning permits.
- (f) IN ADDITION, THE BOROUGH ZONING OFFICER SHALL HAVE THE POWER TO REVOKE ANY PERMIT AND ISSUE A STOP-WORK ORDER WHERE THE REQUIREMENTS OF THIS CHAPTER ARE BEING VIOLATED, AND TO ISSUE VIOLATION NOTICES ASSESSING A PENALTY OF \$200 PER DAY UNTIL ANY SUCH VIOLATION IS ABATED AND BROUGHT INTO COMPLIANCE.
- (g) To prepare a monthly report for the Mayor and Council summarizing all activities of the previous month concerning the duties of the Zoning Officer.

- (2) The Zoning Officer shall be deemed to be the administrative officer as defined in N.J.S.A. 40:55D-3 and shall issue certifications on behalf of the Borough of Barnegat Light certifying whether or not a subdivision has been approved by the Planning Board in accordance with N.J.S.A. 40:55D-56.
- (3) The Zoning Officer shall conduct field inspections and special investigations to ensure compliance with the zoning ordinances and the various land use ordinances of the borough and initiate necessary legal action against violators of such ordinances in the Municipal Court and, with the prior approval of the Mayor and Council, in the Superior Court of New Jersey. In addition, the Zoning Officer shall have the power to revoke any permit and issue a stop-work order where the requirements of this chapter are being

Article XIV CODE ENFORCEMENT OFFICER

§ 32-52. Powers and duties.

The Code Enforcement Officer shall conduct field inspections and special investigations to ensure compliance with variance municipal ordinances, enforce rules and regulations related to the enforcement of ordinances, prepare reports, maintain files and records, and perform all such duties as are assigned from time to time by the Mayor, Borough Council and/or Borough Administrator.

IN ADDITION, THE BOROUGH CODE ENFORCEMENT OFFICER SHALL HAVE THE POWER TO REVOKE ANY PERMIT AND ISSUE A STOP-WORK ORDER WHERE THE REQUIREMENTS OF THE BOROUGH'S ORDINANCES ARE BEING VIOLATED, AND TO ISSUE VIOLATION NOTICES ASSESSING A PENALTY OF \$200 PER DAY UNTIL ANY SUCH VIOLATION IS ABATED AND BROUGHT INTO COMPLIANCE.

ORDINANCE 2022-08

AN ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 180 OF THE BOROUGH CODE, ENTITLED "SWIMMING POOLS," TO REVISE THE REGULATIONS PERTAINING TO THE SAME.

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

SECTION 1. Section 180-2 of Chapter 180 of the Borough Code of the Borough of Barnegat Light, entitled "Definitions," is hereby amended and supplemented to provide as follows: Chapter 180

SWIMMING POOLS

§ 180-2. Definitions.

As used in this chapter, the following words shall have the meanings indicated:

. . .

HOT TUB

Any pool installed either above or below the level of the surrounding land, having a surface area of water of 75 square feet or less and designed, used and maintained for bathing purposes.

. . .

SWIMMING POOL

Any private pool, whether permanently constructed or of the portable type, having a depth of more than 18 inches below the level of the surrounding land or having a depth of more than 24 inches when partly or wholly above ground or having a water surface area exceeding 75 square feet, designed, used and maintained for swimming or bathing purposes by an individual for use by his guests and located on the applicant's land or land under the applicant's control, and shall include all buildings, structures, equipment and appurtenances thereto.

. . . .

WADING POOL

Any shallow pool, whether permanently constructed or of the portable type, which is less than 18 inches below the level of the surrounding land, less than 24 inches deep when partly or wholly above ground and less than 75 square feet in water surface area.

All other definitions set forth in Section 180-2 shall remain in full force and effect.

SECTION 2. Section 180-4 of Chapter 180 of the Borough Code of the Borough of Barnegat Light, entitled "Permit required, fees," is hereby amended and supplemented to provide as follows:

\$ 180-4. Permit required; fees.

A. Application. Before excavation or any other work is commenced on the construction of a pool or the alteration, enlargement, remodeling or other improvement thereof, an application shall be made to the Construction Code Official which shall be accompanied by final plans, specifications and reports in duplicate showing the following data:

- (1) Detailed plat plan of the entire property showing existing structures on the premises and adjoining premises, the location of nearby septic tanks, disposal fields and seepage pits and the proposed pool drawn to scale, with pertinent dimensions and grade elevations shown at pool, building and property lines.
- (2) Detailed plans to scale with dimensions and specifications for the construction of the pool or other change in existing pools, including piping arrangement; pumps; water treatment facilities, including operating instructions therefor; source of water to be used and a report showing quality thereof for potable purposes; provisions for emptying pool and disposal of wastewater; and all other facilities proposed by the applicant or required by this chapter.
- B. Exception. Neither an application nor a permit for construction or installation of a wading pool is required.
- C. Issuance of permit. When the plans and specifications are filed in a form complying with this chapter and they have been approved by the Construction Code Official and the Zoning Officer, a permit to construct the same shall be issued. Upon completion, no pool shall be used until inspected by the Construction Code Official and the Zoning Officer, and a certificate of occupancy has been issued by the

Construction Code Official. *ALL POOL CONSTRUCTION AND INSPECTIONS MUST BE COMPLETED WITHIN 60 DAYS OF THE ISSUANCE OF THE PERMIT.*

D. Fees. Fees shall be as set forth in \$76-14A(1)(f) of the Code of the Borough of Barnegat Light. SECTION 3. Section 180-5 of Chapter 180 of the Borough Code of the Borough of Barnegat Light, entitled "Location," is hereby amended and supplemented to provide as follows: \$180-5. Location.

A. No swimming pool shall be constructed or installed on any lot unless a residential dwelling is located upon the lot or unless the lot is located immediately adjacent to the owner's residence.

B. No swimming pool shall be installed within 30 feet of any street line or closer to the street than the existing building setback line, whichever is greater.

C. The distance from any side and the rear lot line to the inside face of the closest swimming pool, wading pool or hot tub wall SHALL NOT BE LESS THAN THE MINIMUM BUILDING SIDE AND REAR SETBACK REQUIREMENTS OF THE ZONE.

D. All pumps and filtration systems shall be located not closer than five feet to any property line, but not interfere with side property setbacks.

E. No swimming pool shall be constructed within 10 feet of the foundation wall of any dwelling, whether such dwelling shall be on the same premises on which the swimming pool is to be constructed or on adjacent premises.

F. The Zoning Board of Adjustment may grant a variance from the provisions of this section in the same manner that other variances are granted under Chapter 215, Zoning.

SECTION 4. Section 180-10 of Chapter 180 of the Borough Code of the Borough of Barnegat Light, entitled "Violations and penalties," is hereby amended and supplemented to provide as follows: \$ 180-10. Violations and penalties.

A violation of this chapter shall be punishable as provided in Chapter 1, General Provisions, § 1-15. IN ADDITION, THE BOROUGH CODE ENFORCEMENT OFFICER SHALL HAVE THE POWER TO REVOKE ANY PERMIT AND ISSUE A STOP-WORK ORDER WHERE THE REQUIREMENTS OF THIS CHAPTER ARE BEING VIOLATED, AND TO ISSUE VIOLATION NOTICES ASSESSING A PENALTY OF \$200 PER DAY UNTIL ANY SUCH VIOLATION IS ABATED AND BROUGHT INTO COMPLIANCE.

SECTION 5. All ordinances of parts of ordinances inconsistent herewith are hereby repealed.

SECTION 6. This ordinance shall take effect immediately upon its enactment after second reading and publication as required by law.

ORDINANCE 2022-09

AN ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 144 OF THE BOROUGH CODE, ENTITLED "RECREATION AND PUBLIC RESORT AREAS," TO CREATE A NEW ARTICLE VI TO BE ENTITLED "MUNICIPAL PICKLEBALL COURTS."

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

SECTION 1. Chapter 144 of the Borough Code of the Borough of Barnegat Light, entitled "Recreation and Public Resort Areas," is hereby amended and supplemented to provide a new Article VI as follows:

CHAPTER 144 RECREATION AND PUBLIC RESORT AREAS

Article VI Municipal Pickleball Courts

§ 144-33. Use of facilities; pickleball badges required; fees.

No person shall use the municipal pickleball courts unless or until they have obtained an annual weekly or daily pickleball badge; such badge must be available for inspection while the person is using the pickleball court.

The pickleball badge shall be procured from the Borough from the beach badge booth attendant, or such other officer or employee of the Borough authorized to issue the same, by paying the fee required herein. An annual-pickleball badge shall be effective for the calendar year in which it is issued.

The pickleball badge fees shall be as follows:

Non-resident annual, badge - \$100 (personalized photo card badge)

Resident annual, badge – FREE (personalized photo card badge)

Non-resident weekly badge - \$20 (personalized photo card badge)

Non-resident daily badge - \$5 (colored paper wristband) Children age 12 & under - FREE

Active military (including their spouses and children when accompanied by the active military member); Gold Star Families and honorably discharged military veterans - FREE

\$ 144-34. Annual badge limitation.

An annual badge shall not be transferable and must not be used or worn by any other person other than the person to whom it is issued. Any person to whom such badge is so issued who permits another person to use his or her badge for the purpose of playing or entering on the municipal pickleball courts shall have his or her badge and pickleball court use privileges revoked.

\$ 144-35. Hours of operation.

The Municipal pickleball courts shall have an 8:00am start time and end at dusk. No use of the courts may begin before this start time. During the hours of operation, a pickleball attendant or beach badge booth attendant may be on-duty who will check for pickleball badges and supervise the use of the pickleball courts.

\$ 144-36. Rules and regulations.

During the hours of operation, a pickleball attendant or beach badge booth attendant may be on-duty who will check for pickleball badges and supervise the use of the pickleball courts.

The pickleball attendant shall have the right to remove any player who is displaying any unsportsmanlike conduct or refusing to adhere to the rules.

Use of Court 1

Court l shall be used by families, renters, novices or other players who do not wish to participate in "open play" in competition with more experienced players.

If no players are using Court 1, the Borough attendant shall allow players waiting to play on courts 2 or 3 to play on Court 1.

If no other players are waiting for Court 1, players are limited to one hour of uninterrupted court time. If other players are waiting for court 1, players on court shall finish their game and vacate court and join rotation of one game on and one game off per group.

Use of Courts 2 and 3

Courts 2 & 3 are designated for use by "open play" or

with competitive players using accepted pickleball rules of play.

The Borough shall establish and enforce such other rules and regulations concerning the use of the pickleball courts as it may deem necessary and proper.

> Article II 144-21

SECTION 2. Section 144-21 of the Borough Code of the Borough of Barnegat Light, entitled "Use of tennis courts; pickleball courts," is hereby amended to remove references to the Borough's pickleball courts, and shall provide as follows:

\$ 144-21. Use of tennis courts.

The Borough tennis courts shall be used exclusively for the game of tennis. All other uses and activities are strictly prohibited on the Borough tennis courts. The Borough reserves the right to use the tennis courts in other ways as they see fit.

SECTION 3. All ordinances of parts of ordinances inconsistent herewith are hereby repealed.

SECTION 4. This ordinance shall take effect immediately upon its enactment after second reading and publication as required by law.
