COMMITTEE REPORTS:

FINANCE: Councilman Spark reported as follows:

- All bills in the amount of \$1,684,885.73 were reviewed and approved by the Finance Committee
- The big ticket items were the county tax, regional school tax and the police contract.

PUBLIC WORKS: Councilman Wellington reported as follows:

- DPW built three garbage corrals and installed them at the street ends and two more will be built.
- 13th Street was milled and paved and the end of 7th Street was also paved. He said it turned out nice. It also saved the Borough a lot of money.
- Mobi mats and roll-ups were removed from the beach.
- Cleaned up beach entrances after the storm
- The paintings in the dog park were taken down

• The fencing at the bay beach was remove for the season

DOCKS AND HARBORS: Councilman Alloway reported as follows:

• Stripers are in and it should be good fishing until Thanksgiving

BEACHES AND PARKS: Councilwoman Reynolds reported as follows:

- The beach badge revenue for 2022 was down from last year by about \$8,000
- The beaches were guarded a couple of weekends after Labor Day
- Dog park revenue was \$8,700-just out of town dogs
- Pickleball revenue was \$8,145 for out of town players
- Pickleball attendants, Stuart and Kelly, did a great job. There was peace and harmony!

Mayor Larson said that you could go to the beach any day and see whales. Councilwoman Foley said the that whales and dolphins were a bigger attraction that the kite festival.

WATER/SEWER: Councilwoman Foley reported as follows:

- The water main break at 10th Street was repaired and repave by Public Works which saved a huge amount of money
- A broken hydrant on 30th Street
- Hydrant flushing on the 12th & 13th
- First reading of the ordinance for the new water rates and billing will start next year

PUBLIC SAFETY: Councilman Mikuletzky reported as follows:

- Court report a part of the meeting minutes
- Reported that the court collected \$2,638.18. \$577.68 in traffic fines, \$1,645 in criminal fines and costs. He said that Fish & game got \$1,575 and the Borough kept \$598

OPEN PUBLIC SESSION:

Mayor Larson asked for a motion to open the open public session.

Rich Brodman, 4 E 10th, said that the BLTA was having a beach clean-up on October 22nd and invited everyone to come. He said that the start time was 9:00am. He identified the areas that they would focus on and groups would go to different street ends. They are supplying grabbers and he presented one to Mayor Larson. Bruce Allen, 1405 Seaview Avenue, talked about the cleanup that he was doing in the dune areas, He said that 13 contractor bags of bottles and cans have already been removed. He saw where two fires had been burning, two pallets, a chair, tiki torches, and tons of broken glass. Sarah Lambert, 1609 Seaview Avenue, asked Mr. Allen if he did anything south of 14th Street. Mayor Larson, Marc Peimer, the tram driver, does a lot of walking and he always picks up trash as he goes. He said that we will be losing him as a tram driver next year and will be sorry to lose him. Rich Brodman, 4 E 10th, asked Councilman Wellington if the DPW was doing any dune fence repair. The councilman replied that no more fencing was being installed. He said that they break easily and become dangerous due to the rusty wires sticking out. He said that dune fencing was installed around the whale that washed up to help build the dunes around it. Sarah Lambert, 1609 Seaview Avenue, thanked DPW for removing the dead pine tree that had fallen. She suggested that if they didn't have anything to do, they could find the dead pines and remove them.

FIRST READING/INTRODUCTION

ORDINANCE 2022-13

AN ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING THE BOROUGH WATER/SEWER ORDINANCE TO PROVIDE FOR REVISED WATER & SEWER RATES, FEES AND CHARGES.

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

SECTION 1. Section 153-17 of Article I of Chapter 153 of the Borough Code of the Borough of Barnegat Light, entitled "Water rates and charges," is hereby amended and supplemented to provide as follows:

Chapter 153 SEWERS AND WATER

Article I

Operation and Supervision of Systems

§ 153-17. Water rates, fees and charges.

The following rates, fees and charges shall be made and collected for the services and facilities of the comprehensive water system, commencing the service year of 2023:

- A. As of January 1, 2023, all commercial and residential establishments shall be metered and the owner must bear the cost of meter, installation, and any and all repairs and maintenance of such meter or meters.
- B. Commercial properties.

The following water rates shall apply to commercial properties/users:

- 1. Commercial property/user flat fee = \$350 per year (\$87.50 per quarter)
 For each additional commercial unit, whether contained in a multi-unit structure or mixeduse project, there shall be an additional residential user flat fee of \$350 per year (\$87.50 per quarter).
- 2. Commercial property/user gallonage use fee: In addition to the flat fee noted above, commercial properties/users shall be charged for gallonage use at the rate of \$0.00268 per gallon of water used in excess of 14,000 gallons.
- C. Residential properties.

The following water rates shall apply to residential properties/users:

- 1. Residential property/user flat fee = \$300 per year (\$75 per quarter)
 For each additional dwelling unit, whether contained in a duplex, apartment, condominium or other multifamily structure or mixed-use project, there shall be an additional residential user flat fee of \$300 per year (\$75 per quarter).
- 2. Residential property/user gallonage use fee: In addition to the flat fee noted above, each residential dwelling unit user shall be charged for gallonage use at the following rates, calculated quarterly:

- 3. Notwithstanding any provision to the contrary, effective January 1, 2023 all new residential construction, and major renovations to any structure, including residential dwelling units, shall install remote-read water service connection meters and meter pits, in accordance with the specifications adopted by the Borough Superintendent. No Certificate of Occupancy for any such new construction or renovation shall be issued until a certification of the installation of the appropriate water meter is provided by the Borough Superintendent to the Construction Code Official. For the purpose of this subsection, major renovation shall mean any repair, reconstruction, rehabilitation addition, or other improvement of a structure, the cost of which equals or exceeds 50% of the assessed value of the structure either before the improvement is started or if the structure has been damaged and is being restored before the damage occurred. Substantial improvement is commenced when the first alteration of any structural part of the building is begun.
- 4. All water service connection meters and equipment shall be obtained from a vendor with specifications provided by the water/sewer department.
- 5. Water connection activation/reinspection fee: \$50 (per occurrence)
- 6. Turn Off Fee: \$175 (for the first hour or part thereof), plus \$200 per hour for each hour or part thereof after the first hour
- D. Water service charges for all commercial and residential properties shall be billed and payable quarterly. Payment shall be due on the 15th of the month following the quarter. All quarters shall have a 10-day grace period before interest charges begin to accrue. Interest charged on late payments shall be calculated from the due date. In the event of unforeseen circumstances, the Mayor and Borough Council may adjust the due dates and grace periods as determined by Resolution of the governing body.

1ST quarter (January-March) shall be due on April 15th

2nd quarter (April-June) shall be due on July 15th

3rd quarter (July -September) shall be due on October 15th

 4^{th} quarter October-December) shall be due on January 15^{th}

SECTION 2. Section 153-29 of Article II of Chapter 153 of the Borough Code of the Borough of Barnegat Light, entitled "Sewer rates and charges," is hereby amended and supplemented to provide as follows:

Chapter 153 SEWERS AND WATER Article II

Sewer Use

§ 153-29. Sewer rates, fees and charges.

The following rates, fees and charges shall be made and collected for the services and facilities of the comprehensive sewerage system commencing the 2023 service year:

A. Residential properties.

The following sewer rates shall apply to residential properties/users:

- 1. Flat fee for each single dwelling unit, whether contained in single-family residence, duplex, apartment, condominium or other multi-family structure or mixed-use project: \$475 annually (118.75 per quarter)
- 2. For each additional dwelling unit, whether contained in a duplex, apartment, condominium or other multi-family structure or mixed-use project: \$475 annually (118.75 per quarter)
- 3. In addition to all the above pertaining to a multifamily structure and project, all metered use attributable to the multifamily structure or project, without regard to form of ownership, and not attributable separately to each dwelling unit, shall be charged to the owner, occupant or association as the case may be, according to the commercial establishment schedule set forth below.

- B. Sewer service charges for all commercial and residential properties shall be billed and payable quarterly, Payment shall be due on the 15th of the month following the quarter. All quarters shall have a 10-day grace period before interest charges begin to accrue. Interest charged on late payments shall be calculated from the due date. In the event of unforeseen circumstances, the Mayor and Borough Council may adjust the due dates and grace periods as determined by Resolution of the governing body.

 1ST quarter (January-March) shall be due on April 15th

 - 2nd quarter (April-June) shall be due on July 15th
 - 3rd quarter (July -September) shall be due on October 15th
 - 4th quarter October-December) shall be due on January 15th

C. Commercial Sewer

The following rates shall apply to commercial properties/users sewer charges:

- 1. Commercial property/user flat fee = \$475 annually (118.75 per quarter)
- 2. Commercial property/user gallonage use fee: In addition to the flat fee noted above, commercial properties/users shall be charged for gallonage use at the rate of \$0.00268 per gallon for each gallon in excess of 14,000 per quarter
- 3. When a property requires a disconnect from the sewer system, the owner and plumber shall be responsible for disconnecting the sewer and capping the sewer lateral. The water and sewer department will require 48 hours notice prior to installation/disconnection in order to schedule an inspection. An inspection fee of \$50 will be required for each sewer service lateral.
- 4. Inspection of disconnected sewer and cap: \$50
- 5. Turn Off Fee: \$175 (for the first hour or part thereof), plus \$200 per hour for each hour or part thereof after the first hour

SECTION 3. All ordinances of parts of ordinances inconsistent herewith are hereby repealed.

SECTION 4. This ordinance shall take effect immediately upon its enactment after second reading and publication as required by law
