RESOLUTION OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE EXECUTION OF CHANGE ORDER NUMBER – 1 FINAL TO THE 2020 ROAD CONSTRUCTION PROJECT-WEST 13TH STREET CONTRACT WITH MATHIS CONSTRUCTION CO.
