THE CAUCUS MEETING of the Mayor and Council was called to order by Mayor Larson at 4:30pm the at the Barnegat Light Borough Hall, 10 East 7<sup>th</sup> Street, Barnegat Light, NJ. He stated that adequate notice of this meeting has been provided in accordance with the NJ Open Public Meetings Act. Notice of this meeting was posted on the bulletin board in Borough Hall and was published in the Asbury Park Press and Beach Haven Times on January 19, 2023, both newspapers designated by Mayor and Council to receive such notice.

ROLL CALL: Spark, Wellington, absent Alloway, Reynolds, Foley and Mikuletzky

Also present: Mayor Larson, Terry Brady, Sponge Washburn, Michele Inman, Kay Giberson and Brenda Kuhn

Discussion: There was a discussion about the speed limit on Bayview Avenue. Mayor Larson said that this issue was discussed at the Taxpayers' Association meeting. Mayor Larson said the County Commissioners said that the Borough would have to adopt an ordinance for them to lower the speed limit. The mayor said that there was an ordinance on the agenda tonight.

Councilwoman Foley raised a question to Mayor and Council about reinstating memorial benches. There was a discussion regarding this topic. There was mix feelings about this project. The mayor suggested that the council come up with something for next month.

Councilwoman foley said that a couple of residents asked her about a favorite band that wasn't on the list for our summer concert series this year. The residents said that they would like to pay for the band if the Borough would tack another concert onto our schedule, possibly Labor Day or a different week day. The councilwoman said that she would get details for next month.

Mayor Larson brought up the issue of bamboo. Sponge Washburn had ordinances from two towns which were very similar. He said that he like that there was abatement and fines included in these ordinances. There was discussion about this topic. Terry Brady, Municipal Attorney, said that he drafted an ordinance. Councilman Wellington said that DPW went to 3<sup>rd</sup> Street and cleared out a section of bamboo that filled a dumpster and it was still thick in there. He added that DPW will be purchasing a hedgehog which will help with removing this invasive plant and useful for other jobs too.

Mayor Larson asked for a motion to close the Caucus.

Tim Brindley, 1404 Bayview Avenue, commented that the young people in Barnegat Light are a great group. He said that Jack's Point is full of wildlife. Osprey, oystercatchers, blue herons and night crowned herons can be seen there.

Kay Giberson, 7 West 26<sup>th</sup> Street, commented on the nonregistered kayaks and she said that a lot of the owners aren't Barnegat Light residents. She asked if there was an ordinance regarding parking boat trailers along Bayview Avenue. The mayor said that it was the lifeguard boat trailer.

Richard Brodman, 4 East 10<sup>th</sup> Street, said there would be a Taxpayers' Association general meeting at the First Aid Squad Building on July 22, 2023. He said that the first speaker would be Brianna who will talk about nesting birds in Barnegat Light. The second speaker will be Mark Pojednic, Captain of the First Aid Squad, he will be discussing CPR and the use of a defibrillator. He added that the Taxpayer's Association will be donating a defibrillator to the town to use at the pavilion or the pickleball courts. Dr. Brodman said there was a lot planned for September. Some of the things are a showing of the movie Drift at the pavilion, beach cleanup will be on the second Saturday and the final meeting will be September 30th. He said the topic will be the History of the Barnegat Light Fishing Industry.

Jean Birdsall, 1704 Bayview Avenue, & Belinda Decker, 28 west 3<sup>rd</sup> Street, were at the meeting to inform the Mayor and Council about the Hands Across the Beach event that was being held on Saturday. This event is to protest windmills. The women asked if the council would waive the requirement for beach badges and to waive the parking restriction on Central Avenue. The mayor asked for an all in favor. Everyone was in favor

Bruce Theuerkauf, 9 East 19<sup>th</sup> Street, asked if there was going to be an introduction of an ordinance for bamboo.

Sheila Bergey, 8 West 3<sup>rd</sup> Street, said she was involved with the Long Beach Island Foundation Annual House tour on August 2, 2023 10:30 to 4:30. She said there were six houses on the tour and all are on the north end. Tickets are available and they are looking for volunteers.

Allan Canter, 1 West 29<sup>th</sup> Street, wanted to thank John Schulze, Lifeguard Captain, for keeping everyone

on the beach safe. He said that John was doing an excellent job. He added that our lifeguards are the best trained and managed.

Jeff Jorda, 2807 Central Avenue, asked if the helicopter still lands in the dog park

Councilwoman Reynolds asked if Council wanted Councilman Wellington to come up with a plan for the proposed small dog are at the dog park. All were in favor.

#### RESOLUTION 2023-074

RESOLUTION OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE EXECUTION OF AN INTEROCAL/SHARED SERVICE AGREEMENT WITH THE TOWNSHIP OF LONG BEACH FOR LEGAL SERVICES RELATING TO THE OPPOSITION TO THE OFFSHORE WIND PROJECT.

WHEREAS, the Township of Long Beach has taken the lead in the opposition to the Atlantic Shores offshore wind project, including the retaining of special legal counsel for the purposes of asserting said opposition; and

WHEREAS, it is the desire of the Borough of Barnegat Light, as well as all other municipalities on Long Beach Island, to join in said opposition and enter into an interlocal/shared service agreement for special legal services relating to the opposition to the offshore wind project; and

WHEREAS, The Interlocal Services Act, N.J.S.A. 40A:8A-1, repealed, now the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-4, provides that any local unit may enter into an agreement with any other local unit to provide or receive any service that each local unit participating in the agreement is empowered to provide or receive within its own jurisdiction, including services incidental to the primary purposes of any of the participating local units, when approved by resolution under N.J.S.A. 40A:65-5.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

1. That the Mayor and Borough Council of the Borough of Barnegat Light do hereby authorize the execution of a interlocal/shared services agreement with the Township of Long Beach, as lead agency, to engage special legal counsel relating to the opposition to the Atlantic Shores offshore wind project.
2. That the Borough does further authorize the law firm of Pashman, stein, Walder & Hayden to act as special legal counsel to the Borough in accordance with its agreement for legal services with Long Beach Township.
3. That the Borough does further authorize the payment of \$10,000.00 to Long Beach Township as the Borough's contribution towards said legal services, to be paid on or before January 31, 2024.
4. That a certified copy of this resolution shall be forwarded to the Township of Long Beach and to the law firm of Pashman, stein, Walder & Hayden

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

**SECTION 1.** Section 76-14 of the Borough Code of the Borough of Barnegat Light, entitled "Fee schedule," is hereby amended and supplemented to provide as follows:

Chapter 76

Construction Codes, Uniform

**§ 76-14. Fee schedule.**

A. The following fee schedule is hereby adopted and established for the following construction subcodes:

- (1) Building subcode fees shall be as follows (there shall be a minimum building subcode fee of \$50):
  - (a) New construction. Fees for new construction shall be based upon the volume of structure. Volume shall be computed in accordance with N.J.A.C. 5:23-2.28. Use groups and types of construction are as classified and defined in Articles 3 and 4 of the Building Subcode.
    - [1] New residential construction, per cubic foot of volume: \$0.040.
    - [2] Other use groups.
      - [a] Use Groups A-1, A-2, A-3, A-4, F-1, F-2, S-1 and S-2: \$0.013.
      - [b] Structures on farms, including commercial farm buildings under N.J.A.C. 5:23-3.2(d): \$0.0005. The maximum fee shall be \$815.
  - (b) Renovations, alterations and repairs. The fee shall be based on estimated cost of the work. To determine estimated cost, the applicant shall submit to the Construction Code Official such cost data as may be available produced by the architect or engineer of record or by a recognized estimating firm or by the contractor. A bona fide contractor's bid, if available, shall be submitted. The Construction Code Official shall make the final decision regarding estimated cost.
    - [1] From \$1 to \$50,000: \$35 per \$1,000.
    - [2] From \$50,001 to \$100,000: add \$20 per \$1,000.
    - [3] Over \$100,000: add \$16 per \$1,000.
    - [4] Roofing or siding in R-3 and R-4 uses: \$50.
  - (c) Additions. Fees shall be computed on the same basis as for new construction for the added portion.
  - (d) Combination renovations and additions. Fees shall be computed separately in accordance with Subsection A(1)(b) and (c).
  - (e) Temporary structures. The fee for temporary structures, towers, fences greater than six feet in height, open decks not attached to a principal or accessory structure and similar structures for which volume cannot be computed shall be \$35.
  - (f) Pools.
    - [1] Aboveground: \$35.
    - [2] In-ground: \$250.
    - [3] Commercial: \$250.
  - (g) Bulkheads, docks, wharves and piers. The fees shall be computed as an alteration.
- (2) Plumbing Subcode fees shall be as follows (there shall be a minimum plumbing subcode fee of \$65):
  - (a) For each of the following: \$15
    - [1] water closet
    - [2] urinal/bidet, bath tub
    - [3] lavatory

- [4] shower
  - [5] floor drain
  - [6] sink
  - [7] dishwasher
  - [8] drinking fountain
  - [9] washing machine
  - [10] hose bibb
  - [11] water heater
  - [12] stacks
  - [13] gas appliance connection
  - [14] other fixtures
- (b) For each of the following: \$77.35

  - (a) Plan review fee: 20% of the amount to be charged for a new construction permit.
  - (b) Basic construction fee: the sum of the parts computed on the basis of the volume or cost of construction, and the number of sprinklers, standpipes and detectors (smoke and heat) at the unit rates provided herein, plus any special fees.
  - (c) Certificates and other permits.
    - [1] Demolition or removal permit.
      - [a] Structures less than 5,000 square feet in area and less than 30 feet in height, for one- or two-family residences (Use Group R-3 of the Building Subcode): \$100.
      - [b] All other use groups: \$120.
    - [2] The fee for a permit to construct a sign shall be in the amount of \$1 per square foot surface area of the sign, computed on one side only for double-faced signs.
    - [3] Certificate of occupancy: \$50.
    - [4] Certificate of occupancy granted pursuant to a change of use group: \$75.
      - [a] \$50 to Building.
      - [b] \$25 to Fire.
    - [5] Certificate of continued occupancy: \$60.

    - [6] Reinstatement of lapsed permit: \$35 per subcode.
    - [7] Annual permits. The fee to be charged for an annual construction permit shall be charged annually. This fee shall be a flat fee based upon the number of maintenance workers who are employed by the facility, and who are primarily engaged in work that is governed by a subcode; managers, engineers and clericals shall not be considered maintenance workers for the purpose of establishing the annual construction permit fee. Annual permits may be issued for building and fire protection. Fees shall be as follows:
      - [a] Workers (including foremen), each:
      - [b] One to 25: \$667.
      - [c] Each additional over 25: \$150.
      - [d] Prior to issuance of an annual permit, a training registration fee of \$140 per subcode shall be submitted by the applicant. Checks shall be made payable to "Treasurer, State of New Jersey."

(6) Fees applicable to Subsection A(2) through (4) above shall have additional fees added to create an Administrative Fee of 25% per permit, for the purpose of covering a proportionate share of administrative costs incurred by the Borough in connection with inspections performed by a private agency.

B. A schedule of the construction and subcode fees established by this chapter shall be posted in the office of the Construction Code Official and shall be made available to the public.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required by law.
