THE CAUCUS MEETING of the Mayor and Council was called to order by Mayor Larson at 4:30pm at the at the Barnegat Light Borough Hall, 10 East 7th Street, Barnegat Light, NJ. He stated that adequate notice of this meeting has been provided in accordance with the New Jersey Open Public Meetings Act. Notice of this meeting was posted on the bulletin board in Borough Hall and was advertised in the Asbury Park Press and Beach Haven Times on February 1, 2024.

ROLL CALL: Spark was absent, Wellington, Gutowski, Reynolds, Foley and Mikuletzky

Also present: Mayor Larson, Terry Brady, Sponge Washburn, Michele Inman, John Schulze and Brenda Kuhn

Discussion: The NJDEP mandated tree ordinance was discussed. Terry Brady, Municipal Attorney, said that he compiled all of the information regarding trees that was currently in the Borough Code Book. He sent it to the DEP for review to see if further action would be necessary. There was more discussion on this topic.

Terry said that another ordinance that the NJDEP is requiring, pertained to the storage of deicing material. He said that it should not be stored in a big pile outside. Runoff is the issue.

The conversation led to weeds and the issue of herbicides. Councilwoman Foley said that that For-Shore Weed Control has a permit from the DEP to spray right up to the water line.

Mayor Larson asked for a motion to close the Caucus. On a motion by Foley, seconded by Gutowski and carried by all the Caucus Meeting was closed.

The next topic was the Stormwater Management Ordinance that was also mandated. Terry said the ordinance is 40 pages. He said we have adopted a few of these ordinances over the last few years. He talked to the DEP and they said there was a simplified version makes references to the Administrative Code where updates can be reviewed. He said that it would be a better option than doing a new ordinance time and time again for miniscule changes.

Councilwoman Reynolds has what could be done to implement MyBeachMobile for the ramp and beach badges and asked if she or Councilman Gutowski could contact them to get it started. Terry said that the QPA should be negotiating an agreement.

There was discussion about a marina proposing moorings. Grant money is available from state and the moorings portion of the plans are an important part of the proposal to get the funding. The council was concerned about the number of moorings.

Volunteers have planted some cedar seedlings and goldenrod. He also told the Council for their plans for fall planting.

Lynne Skead, 3 East 8th Street, asked for help with the overgrowth of poison ivy on the beach walkway at 8th Street. Councilwoman Reynolds said that we will be looking into it.

Connie Pinkowski, 4 East 26th Street, asked if sand could be put in the holes at the baby beach. Councilman Wellington said the intention was to bring up beach sand and fix it but Councilwoman Reynolds didn't want it. There was a discussion about this.

Connie Higgins, 10 East 11th Street, wanted to know if the council and attorney had a definition of a kitchen in regards to the water bill for her duplex. Terry Brady addressed her question. He said that if you have a two-family home, you pay flat rate for both units.

Jim Peavy, 26 West 7th Street, had concerns about the traffic situation on West 7th and the parking on both sides of the street. He said it was a safety issue. He asked the council to consider parking on only one side of the street. Anne Peavy said it was a tragedy waiting to happen.

Councilman Mikuletzky had questions regarding the marina plans. Tom MacArthur addressed his questions. Council thought that the moorings were too close to the channel.
