Discussion: Councilwoman Reynolds read a letter about the character of Barnegat Light. She proposed to introduce an ordinance to remove hotels and motel as a permitted land use. She said hotels would create overcrowding, more traffic, noise, activity and strain on the roads and water/sewer system. It would also expand the demand on emergency services. Terry Brady, Municipal Attorney, spoke in depth about the process of amending the master plan and sound planning. He warned council to be cautious about zoning regulations.

Councilman Spark asked for a motion to close the Caucus. On a motion by Foley, seconded by Gutowski and carried by all the Caucus Meeting was closed.

COMMITTEE REPORTS:

FINANCE: Councilman Spark reported as follows:

Bills for the month are \$2,868,869.38

Kathleen Flanagan, CFO, told the Governing Body that a Bond Anticipation Note was sold at open market for \$2,131,000 with interest rate of 4.25%. On another note, the audit report was completed and there were no findings, therefore no corrective action is needed. She said there was a breakdown of the taxes was available if anyone was interested.

PUBLIC SAFETY:

Councilman Mikuletzky reported as follows:

- Revenue was \$2,388.81
- There was an EOC meeting to discuss procedures and upgrades.
- Working on LOSAP

Councilman Wellington said that we are required to upgrade the emergency operations plan every two years. He said that it was a preliminary meeting with a consultant. Once our plan is completed it will be submitted to the County and then the county submits to the state. If we follow the preparedness plan and FEMA allocated money, we would be eligible to apply for funding for damages and expenses.

WATER/SEWER Councilwoman Foley reported as follows:

BEACHES AND PARKS: Councilwoman Reynolds reported as follows:

- Beach badge revenue is up from last year
- Paw pass and pickleball revenue are both down

DOCKS AND HARBORS: Councilman Gutowski reported as follows:

- Revenue is up for the boat ramp and kayak area
- Talked about offshore wind
- Tile fish and scallops are coming into season

PUBLIC WORKS: Councilman Wellington reported as follows:

- Regular maintenance
- Post Office building is being sided

Rich Brodman, 4 E 10th, was speaking on behalf of himself and the BLTA membership, he said that almost everyone agrees with Dottie. They don't want future development of hotels and motels because of the stress that it would put on the Rescue squad, Fire Company, and the water/sewer systems. Also, there would be more people and traffic. They would love to see more businesses such as restaurants, bars and shops.

James Murtaugh, 13 W 5th, wanted to know about the process to update the master plan. He thought that it was essential to begin that process. Terry Brady, Municipal Attorney, addressed his question. The process is a Planning Board function.

Paula Mainardi, 8 E 24th, asked about the process to get the Planning Board to update the Master Plan. Ed Wellington addressed her inquiry.

Nancy Connelly, 19 W 5th, said that the Master Plan was a public document and asked how the members of the community elicit an amendment to the Master Plan. if the master plan was amended to prohibit hotels and motels, could an ordinance change that down the road? Terry Brady said that the Master Plan was a policy document and an ordinance is the law of this town.

Madeline Pantzer, 4 E 8th, talked about the lack of white sandy beached north of 16th street and affordable housing. She said it was time to review the Master Plan.

Bob Birdsall, 1704 Bayview Ave, said we should keep the heritage of our town.

Steven Mainardi, 8 E 24th, asked if hotels were allowed in the marine commercial zone and if so, he urged everyone to show up at the planning board meeting and press them.

Lisa Dolan, 2310 Bayview Ave, inquired when the Master Plan was created. Terry Brady said probably 40 years. She wanted to know who the governing force was and Terry said it was the

Planning Board.

Marlena Christensen, 4 W 24th, asked about condominiums.
