MEMORIALIZE RESOLUTION 2024-06 APPLICATION 2024-03

AT THIS TIME, Chairman Mescolotto asked for a motion to memorialize application 2024-03, resolution 2024-06 Bayview Harbor LLC.

OLD BUSINESS: AFFORDABLE HOUSING

The planning board discussed the state's new law mandating towns to provide a minimum number of affordable housing units. Mescolotto explained that the current plan will require Barnegat Light to have 64 units. In response, he proposed forming a subcommittee to develop recommendations to town council, including potential amendments to the master plan to address the mandate.

Board member, Brindley asked if the state's determination of the required affordable housing units was influenced by Barnegat Light having a different zip code than the neighboring towns on Long Beach Island. The Chairman responded that he believes the data was ascertained by the town's property records and not by Barnegat Light's zip code.

Board member, Snieckus asked whether the planning board's recommendation would challenge the state's requirement of 64 units. Mescolotto explained that there will be an audit of the property record data that was used by the state to come up with those 64 units. This audit will determine if there was a mistake in the town's records that could have led to a miscalculation.

The board further expressed that this law isn't practical for a small town like Barnegat Light. These impracticalities are due to lack of public transportation and lack of financial incentive for land developers to construct affordable housing. Washburn explained that although it seems impractical it is still imperative that the borough comply with the law. The board agreed.

Ultimately, the board agreed to form a subcommittee to address the affordable housing mandate. The subcommittee will consist of Chairman Mescolotto, Mayor Larson and Jeffrey Washburn.

AT THIS TIME, Chairman Mescolotto asked for a motion to open to the public

Michael Spark of 2610 Bayview approached the board and recommended that the town hire professionals specializing in affordable housing issues. Spark emphasized the importance of meeting the upcoming deadline for submitting a plan to the state and urged the board to act promptly.

Richard Brodman of 4 East 10th St. approached the board and expressed that he believes the board should hire an expert to address the affordable housing mandate.

Antoinette Murphy approached the board and expressed her agreement with Spark and Brodman.

Washburn and Chairman Mescolotto assured the public that there is a plan in place and hiring outside help may be an option if deemed necessary upon further findings by the committee.
